PAC is for middle and high school youth who have been referred by juvenile court or schools.

The goal of the class is to help youth make better, more peaceful choices. Statistics show that youth who have taken the class have a lower rate of repeating their original negative choice.

Mediation Services is a private, non-profit organization providing free or low cost mediation services for community issues (neighbors, landlords and tenants, businesses and consumers), co-parenting issues, and parenting expediting. Anyone who lives in Anoka County can use these services.

Mediation is a voluntary process used to settle disputes. Parties involved in a dispute meet with trained, impartial people called mediators.

Mediators listen to both sides, maintain order, and assist the parties in reaching their own agreement. Mediation is not legally binding.

The mediators are volunteers from the community who are trained according to Minnesota Statutes. Mediators represent a variety of backgrounds, interests and occupations.
